- B Macfarlane presented an Operational update. Currently filling Cell 20B. Will ensure the tip pad will be kept low over the Christmas period to help avoid a repeat of last years' complaints. At full capacity with ops staff (17). Rob Bailey resigned in June and Lewis Morgan is our new Ops Manager. Other changes include Allan Dyson stepping back with Glen Jujnovich taking over as Generation Manager and Kamal Prakash as Workshop Supervisor.
Approaching Earthworks season (October). Ponds are clean and in good working order. The sludge taken from the ponds is tested and put into landfill. Managed Fill is down and trucks are down to around 180 per day. Smaller loads are being diverted to transfer stations to consolidate into bigger loads. Out of approx. 325 trucks 14% is residential waste. Still forecast for closure in 2028.

Complaints:

- The WMNZ Register of Complaints was presented. L Taylor confirms she has received a complaint from local Steve Thomas. V Hermanto keeps in regular contact with Steve. B Macfarlane spent a few weeks of early mornings monitoring up at the tip face. Will not open the cap until sufficient odour suppressant is in place. Also noted that an extra tee bar is required for behind the Workshop. L Taylor to follow up with Councils odour register. Redvale and Council need to provide a combined report.

Regulatory Issues:

General Business:

- J Hutchinson discusses generators. Has done some research into completely housing the generators. Blair explains this is costly and the heat control would be difficult to manage. 40 decibels is our consent limit. In June a storm blew up our switch and is due to be replaced in October. This means we are unable to run all generators at once for a

Marshall Day noise report. Our original generators are not enclosed, however our most recent 2 are surrounded by 3 walls. We are replacing G2 next year. J Hutchinsons concern around noise is noted.

- Pest control – J Hutchinson notes a significant amount of mynah birds nesting in the area. Would like to see more possum traps around the perimeter. Encourages a group effort rather than just one or two people.
- Rubbish along the highway: WM provide a team to pick up litter 1km either side of Landfill Access Road. Clean the highway itself once a quarter
- Auckland Regional Landfill consent has been lodged. Public will be able to make submissions.
- Percentage air space to fill: 31.72%
Percentage of landfill, filled: 68.28%
Percentage of landfill final cap completed: 28.23%
Percentage of landfill final cap still to complete: 71.77%
